PRE-EVENT REGISTRATION AND VENDOR/DISPLAY AGREEMENT BACKGROUND.

A. Parties. This Agreement (“Agreement”) is entered into on this ____ day of _____, 2019 between Mid America Muscle Car, LLC. Whose address is P.O. BOX 57816, OKLAHOMA CITY, OK 73157 U.S.A. (“MAMC”), and _____, a _____ whose address is _____ (“Vendor”)?

B. Purpose. The purpose of this agreement is to provide a registration and vendor/display agreement between MAMC and _____. The parties therefore agree as follows:

SECTION 1. EVENT REGISTRATION

1.1 Registration. A onetime fee of \$100 per table will be charged by MAMC to Vendor in connection with the general registration and vendor display at the Mid America Ford and Shelby Nationals (Event), to be held June 12-16, 2019. The Vendor is not allowed to set up and sell items at the Tulsa Marriott Southern Hills outside in the parking lot until Sunday the 17th June, 2018.

SECTION 2. QUALITY & COMPLIANCE

- 2.1 Quality.** Vendor agrees to make best efforts to display and represent high quality products while at Event.
- 2.2 Compliance.** Vendor agrees to comply with all MCE’s established event rules and regulations.

SECTION 3. COPYRIGHT, TRADEMARKS.

- 3.1 Copyright, Trademarks.** Vendor agrees that all Merchandise and Collateral Materials are produced under all necessary applicable license and will bear all required trademark symbols and any other credits or legal notices required by the owner of said trademarks and/or licensor
- 3.2 Compliance with Intellectual Property Laws.** This Agreement is conditioned upon Vendor’s full and complete compliance with the provisions of the trademark, patent, and copyright laws of the United States.

SECTION 4. RESERVATION OF RIGHTS.

- 4.1 Rights Expressly Reserved by MAMC.** Any and all rights not expressly granted to Vendor hereunder are expressly reserved by MAMC.
- (A) Nothing contained in this Agreement may be construed as an assignment or grant to Vendor of any right, title, or interest in or to any copyrights, trademarks or patents therein or associated therewith.
- (B) It is understood that all rights thereto are reserved by MAMC, except for the grant of rights to register and display at the Event expressly provided in this Agreement.
- 4.2 Licensee’s Indemnification.** Vendor must indemnify, hold harmless and defend MAMC, its officers, directors, agents and employees against any and all claims, suits, losses, damages, costs and expenses, including reasonable attorney’s fees, which may be

suffered or incurred by MAMC which arise out of or in connection with the attendance and sale of merchandise at event

SECTION 5. GOVERNING LAW AND JURISDICTION.

- 5.1 Governing Law.** This Agreement is entered into and must be enforced, interpreted and construed in accordance with the laws of the State of OKLAHOMA, United States of America.
- 5.2 No Waiver by MAMC.** None of the foregoing provisions will in any way be deemed a waiver of MA's rights to proceed with litigation against Vendor in any other appropriate venue or jurisdiction.

SECTION 6. MODIFICATION.

Entire Understanding. This agreement is the sole Agreement between the parties and cancels and supersedes any and all prior written or oral representations and agreements between the parties.

SECTION 7. EFFECTIVE UPON EXECUTION.

- 7.1 Full Execution.** This Agreement made as of the date at the top of this Agreement. This Agreement is effective only upon full execution by MAMC and Vendor.

SECTION 8. LIABILITY INSURANCE.

8.1 Each Vendor must present a copy of their Liability Insurance Certificate naming Mid America Muscle Car and Mid America Ford and Shelby Nationals. Insurance can be purchased from K & K Insurance CONCESSIONAIRES, EXHIBITORS & VENDORS Insurance Program and Enrollment Form.
